State of Rhode Island Monthly Hotel Report FY 2011 1.0 Percent Local Collections October 2010

Beginning in June 2010, the Rhode Island Department of Revenue will issue a report on the collection and distribution of the 1.0 percent local Hotel Tax. The report is meant to be descriptive and does not purport to project or assess the collection of the 1.0 percent local Hotel Tax. The report will provide data, by municipality, on the month-to-month, the year-over-year, and the fiscal year-to-date collections. A discussion of the municipalities with the largest and smallest percentage changes in these three measures will be included in the body of the report.

Analysis of Month-to-Month Collections

On a statewide basis, October 2010 local hotel collections totaled \$264,985 or 15.4 percent less than the \$313,117 collected in September 2010. The five communities with percentage increases in local hotel collections between October and September 2010 were: Little Compton, 5,031.8 percent; East Greenwich, 107.8 percent; Bristol, 33.1 percent; Glocester, 29.0 percent; and Woonsocket, 25.2 percent. The five communities with the largest percentage decrease in local hotel collections between October and September 2010 were: Smithfield, -73.2 percent; Charlestown, -59.3 percent; New Shoreham, -56.0 percent; Coventry, -44.0 percent; and Portsmouth, -36.5 percent.

The five communities with the largest nominal increase in local hotel tax collections between October and September 2010 were: Providence \$7,589; Warwick, \$3,171; Little Compton, \$1,057; Bristol, \$480; and Lincoln, \$366. The five communities with the largest nominal decrease in local hotel tax collections between October and September 2010 were: Newport, -\$30,663; Middletown, -\$11,158; New Shoreham, -\$6,765; Smithfield, -\$3,213; and Westerly, -\$2,034.

Analysis of Year-over-Year Collections by Month

On a statewide basis, October 2010 local hotel tax collections totaled \$264,985 or 11.1 percent more than the \$238,532 collected in October 2009. The five communities with the largest percentage increase in local hotel collections between October 2010 and October 2009 were: Westerly, 308.9 percent; Cranston, 216.2 percent; East Greenwich, 65.6 percent; and Bristol and

East Providence, 58.9 percent. The five communities with the largest percentage decrease in local hotel collections between October 2010 and October 2009 were: Smithfield, -71.3 percent; Little Compton, -44.9 percent; Coventry, -28.5 percent; West Greenwich, -22.8 percent; and West Warwick, -14.9 percent.

The five communities with the largest nominal increase in local hotel tax collections between October 2010 and October 2009 were: Newport, \$9,746; Providence, \$9451; Westerly, \$6,075; New Shoreham, \$1,921; and Warwick, \$1,631. The five communities with the largest nominal decrease in local hotel tax collections between October 2010 and October 2009 were: Smithfield, -\$2,913; Little Compton, -\$879; Coventry, -\$792; West Greenwich, -\$610; and West Warwick, -\$576.

Analysis of Fiscal Year-to-Date Collections through October

On a statewide basis, fiscal year-to-date October 2010 local hotel tax collections totaled \$1.31 million or 11.4 percent more than the \$1.18 million collected in fiscal year-to-date October 2009. The five communities with the largest percentage increase in local hotel collections between fiscal year-to-date October 2010 and fiscal year-to-date October 2009 were: Little Compton, 90.0 percent; Westerly, 73.7 percent; East Greenwich, 58.9 percent; Charlestown, 56.1 percent; and East Providence, 21.3 percent. The five communities with percentage decreases in local hotel collections between fiscal year-to-date October 2010 and fiscal year-to-date October 2009 were: Cranston, -66.0 percent; Johnston, -21.3 percent; Jamestown, -1.7 percent; Smithfield, -1.3 percent; and West Greenwich, -1.2 percent.

The five communities with the largest nominal increase in local hotel tax collections between fiscal year-to-date October 2010 and fiscal year-to-date October 2009 were: Newport, \$40,774; Westerly, \$37,336; Providence, \$27,944; Middletown, \$6,314; and Warwick, \$4,828. The five communities with the largest nominal decrease in local hotel tax collections between fiscal year-to-date October 2010 and fiscal year-to-date October 2009 were: Cranston, -\$1,699; Johnston, -\$245; Smithfield, -\$206; West Greenwich, -\$162; and Jamestown, -\$40.
