State of Rhode Island Monthly Meal and Beverage Report FY 2011 1.0 Percent Local Collections November 2010

Beginning in June 2010, the Rhode Island Department of Revenue will issue a report on the collection and distribution of the 1.0 percent local Meal and Beverage Tax. The report is meant to be descriptive and does not purport to project or assess the collection of the 1.0 percent local Meals and Beverage Tax. The report will provide data, by municipality, on the month-to-month, the year-over-year, and the fiscal year-to-date collections. A discussion of the municipalities with the largest and smallest percentage changes in these three measures will be included in the body of the report.

Analysis of Month-to-Month Collections

On a statewide basis, November 2010 local meal and beverage tax collections totaled \$1.48 million or 11.9 percent less than the \$1.68 million collected in October 2010. The five communities with the largest percentage increase in local meal and beverage tax collections between November and October 2010 were: Cranston, 10.6 percent; West Warwick, 7.8 percent; North Providence, 4.9 percent; Smithfield, 3.4 percent; and Pawtucket, 3.0 percent. The five communities with the largest percentage decrease in local meal and beverage tax collections between November and October 2010 were: Little Compton, -83.7 percent; New Shoreham, -68.2 percent; Hopkinton, -51.8 percent; Foster, -42.2 percent; and Charlestown, -41.5 percent.

The five communities with the largest nominal increase in local meals and beverage tax collections between November and October 2010 were: Cranston, \$11,565; West Warwick, \$2,173; Pawtucket, \$1,576; Smithfield, \$1,502; and North Providence, \$1,470. The five communities with the largest nominal decrease in local meals and beverage tax collections between November and October 2010 were: Newport, -\$47,783; Providence, -\$43,372; Westerly, -\$14,537; Middletown, -\$13,375; and Bristol, -\$12,135.

Analysis of Year-over-Year Collections by Month

On a statewide basis, November 2010 local meal and beverage tax collections totaled \$1.48 million or 7.0 percent more than the \$1.39 million collected in November 2009. The five communities with the largest percentage increase in local meal and beverage tax collections between November 2010 and November 2009 were: New Shoreham, 66.1 percent; Newport, 53.5 percent; Richmond, 32.7 percent; Central Falls, 30.0 percent; and Glocester, 21.0 percent. The five communities with the largest percentage decrease in local meal and beverage tax collections between November 2010 and November 2009 were: Hopkinton, -39.2 percent; Foster, -36.0 percent; Little Compton, -27.5 percent; Jamestown, -19.2 percent; and Middletown, -15.5 percent.

The five communities with the largest nominal increase in local meals and beverage tax collections between November 2010 and November 2009 were: Newport, \$32,516; Providence, \$18,765; Warwick, \$12,162; Cranston, \$9,116; and Pawtucket, \$8,277. The six communities with the largest nominal decrease in local meals and beverage tax collections between November 2010 and November 2009 were: Middletown, -\$6,412; East Greenwich, -\$5,143; Coventry, -\$2,084; Woonsocket, -\$1,483; and Warren, -\$1,154.

Analysis of Fiscal Year-to-Date Collections through November

On a statewide basis, fiscal year-to-date 2011 local meal and beverage tax collections totaled \$8.84 million or 4.8 percent more than the \$8.43 million collected through fiscal year-to-date November 2009. The five communities with the largest percentage increase in local meal and beverage tax collections between fiscal year-to-date November 2010 and fiscal year-to-date November 2009 were: Bristol, 17.8 percent; Richmond, 15.9 percent; Johnston, 15.0 percent; West Greenwich, 14.7 percent; and Central Falls, 12.4 percent. The five communities with the largest percentage decrease in local meal and beverage tax collections between fiscal year-to-date November 2010 and fiscal year-to-date November 2009 were: Foster, -15.9 percent; Little Compton, -10.6 percent; North Smithfield, -8.4 percent; Jamestown, -3.1 percent; and North Providence, -2.3 percent.

The five communities with the largest nominal increase in local meals and beverage tax collections between fiscal year-to-date November 2010 and fiscal year-to-date November 2009 were: Newport, \$100,680; Providence, \$65,748; Westerly, \$33,488; Cranston, \$30,955; and Johnston, \$25,808. The five communities with the largest nominal decrease in local meals and beverage tax collections between fiscal year-to-date November 2010 and fiscal year-to-date November 2009 were: North Smithfield, -\$5,822; Warwick, -\$4,021; North Providence, -\$3,277; Little Compton, -\$2,694; and Foster, -\$1,425.
