State of Rhode Island Monthly Meal and Beverage Report FY 2012 1.0 Percent Local Collections August 2011

Beginning in June 2010, the Rhode Island Department of Revenue will issue a report on the collection and distribution of the 1.0 percent local Meal and Beverage Tax. The report is meant to be descriptive and does not purport to project or assess the collection of the 1.0 percent local Meals and Beverage Tax. The report will provide data, by municipality, on the month-to-month, the year-over-year, and the fiscal year-to-date collections. A discussion of the municipalities with the largest and smallest percentage changes in these three measures will be included in the body of the report.

Analysis of Month-to-Month Collections

On a statewide basis, August 2011 local meal and beverage tax collections totaled \$1.88 million or 13.9 percent less than the \$2.19 million collected in July 2011. The five communities with the largest percentage increase in local meal and beverage collections between August and July 2011 were: Smithfield, 6.4 percent; Cranston, 5.3 percent; Coventry, 3.4 percent; and North Smithfield and South Kingstown, 1.4 percent. The five communities with the largest percentage decrease in local meal and beverage collections between August and July 2011 were: Bristol, -34.3 percent; Westerly, -31.2 percent; Central Falls, -29.8 percent; Glocester, -28.4 percent; and Newport, -27.8 percent.

The five communities with the largest nominal increase in local meals and beverage tax collections between August and July 2011 were: Cranston, \$6,276; Smithfield, \$2,904; Coventry, \$997; South Kingstown, \$851; and North Smithfield, \$182. The five communities with the largest nominal decrease in local meals and beverage tax collections between August and July 2011 were: Newport, -\$84,079; Westerly, -\$40,038; Providence, -\$29,494; Narragansett, -\$17,313; and New Shoreham -\$16,360.

Analysis of Year-over-Year Collections by Month

On a statewide basis, August 2011 local meal and beverage tax collections totaled \$1.88 million or 6.9 percent less than the \$2.02 million collected in August 2010. The five communities with the largest percentage increase in local meal and beverage collections between August 2011 and August 2010 were: Smithfield, 23.4 percent; Johnston, 9.7 percent; Scituate, 9.5 percent; Coventry, 4.8 percent; and Cranston, 3.6 percent. The five communities with the largest percentage decrease in local meal and beverage collections between August 2011 and August 2010 were: Bristol and Hopkinton, -43.8 percent; Foster, -30.3 percent; Portsmouth, -28.4 percent; and Little Compton, -28.0 percent.

The five communities with the largest nominal increase in local meals and beverage tax collections between August 2011 and August 2010 were: Smithfield, \$9,088; Cranston, \$4,374; Johnston, \$3,264; South Kingstown, \$1,597; and Coventry, \$1,394. The five communities with the largest nominal decrease in local meals and beverage tax collections between August 2011 and August 2010 were: Newport, -\$40,702; Westerly, -\$25,983; Bristol, -\$18,178; Providence, -\$10,486; and Pawtucket, -\$6,530.

Analysis of Fiscal Year-to-Date Collections through August

On a statewide basis, fiscal year-to-date 2011 local meal and beverage tax collections totaled \$4.07 million or 1.7 percent more than the \$4.00 million collected through fiscal year-to-date August 2010. The five communities with the largest percentage increase in local meal and beverage tax collections between fiscal year-to-date August 2011 and fiscal year-to-date August 2010 were: Warren, 25.7 percent; Smithfield, 9.7 percent; Central Falls, 8.8 percent; and Charlestown, and New Shoreham, 6.5 percent. The five communities with the largest percentage decrease in local meal and beverage tax collections between fiscal year-to-date August 2011 and fiscal year-to-date August 2010 were: Hopkinton, -24.9 percent; Bristol, -24.2 percent; Portsmouth, -21.3 percent; Foster, -20.0 percent; and Little Compton, -15.2 percent.

The five communities with the largest nominal increase in local meal and beverage tax collections between fiscal year-to-date August 2011 and fiscal year-to-date August 2010 were: Providence, \$30,463; Warwick, \$22,694; Cranston, \$11,750; Newport, \$11,169; and Warren, \$9,801. The five communities with the largest nominal decrease in local meal and beverage tax collections between fiscal year-to-date August 2011 and fiscal year-to-date August 2010 were: Bristol, -\$18,791; Portsmouth, -\$8,527; West Warwick, -\$6,363; North Kingstown, -\$5,236; and Pawtucket, -\$4,879.
